#### Caring - someone who has....

- -Respected and valued individual differences
- -Supported colleagues and/or volunteers and/or supporters at all times
- -Shared their knowledge and/or expertise with others in the aim to deliver care to people with progressive life limiting illnesses whether clinically or in the support of the clinical care

## Adaptable - someone who has....

- -Responded positively, appropriately and flexibly to challenges
- -Constantly strived to ensure all they did was of high quality and/or compliant in accordance with changing regulations and/or situations
- -Worked across sectors (voluntary, public, and/or private) for the benefit of Trinity
- -Develop effective external collaborations based on mutual respect and trust
- -Was prepared to put the needs of other before their own by demonstrating a flexible and adaptable approach

#### Responsible - someone who has....

- -Clearly communicated expectations so that colleagues, volunteers and/or supporters knew what was required of them and could give of their best
- -Demonstrated a 'can do' attitude and/or was accountable for their individual actions
- -Investigated adverse comments and complaints carefully and honestly, ensured learning and continuous improvement
- -Shared compliments and celebrated successes to learn from good practice
- -Ensured effective teaching and provided exceptional learning opportunities to colleagues
- -Maximised their impact by effective team-working

- -Shared Trinity's expertise to benefit the wider Hospice and Palliative Care community as well as other care providers
